Sri Sai Ram Homoeopathic Medical College and Research Centre, (Sapthagiri Education Trust), Sai Leo Nagar Tambaram West Chennai-600044 Tamil Nadu for Admission in BHMS Course with Intake Capacity of 50 Seats for academic year 2024- 25. The College has submitted the Part 1 information in which the entire functional profile has been narrated. MARB has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards as per the prevailing regulations under NCH Act 2020, as per section 29 and subsection (3) of the Act.

As per the observations made by MARB, following information are provided for immediate rectification of the shortfalls. College shall fulfil all functional requirements as per the Minimum Standard Requirements as mentioned below:-

- **Teaching faculty:** Total 30 fulltime faculty for UG provided but few discrepancies are mentioned below: -
- a) Department of Anatomy No higher faculty, only 2 lectures are available.
- b) In UG Department of Surgery, Pharmacy, Pathology and Microbiology, Obstetrics and Gynecology, Community Medicine, and Repertory–Lecturer is not available.
- c) In UG Department of Organon of Medicine- Dr. Aleena George having discrepancy in appointment as she is not post graduate and hence not eligible for the post of lecturer as per MSR 2013. Only BHMS is mentioned as qualification no MD certificate is provided.
- d) 09 Consultants of Modern Medicine shall be provided with name in attendance and Acquittance role.
- e) 08 Guest Faculty with name in Attendance and Acquittance role shall be provided.
- Hospital facilities:-
- a) IPD/OPD Case sheets shall be maintained with complete case history, analysis and evaluation and repertorisation and made available in the Medical Record Room for academic purpose of students and for follow up attendance of the patients.
- Financial details: Form -16 of staff are not from traces portal.

Considering the above observations, and facilities available, MARB has decided to issue Conditional permission to Sri Sai Ram Homoeopathic Medical College and Research Centre,

(Sapthagiri Education Trust), Sai Leo Nagar Tambaram West Chennai-600044 Tamil Nadu for Admission in BHMS Course with Intake Capacity of 50 Seats for academic year 2024- 25.

All the shortfalls observed in your College shall be rectified within a period of 30 days or before counselling initiates, whichever earlier and compliance report shall be submitted to the MARB, failing which the conditional permission issued will be cancelled without further notice.

All admissions shall be made by NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/ UT govt as designated by Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the central govt for All India quota or the student admitted thereunder.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.
